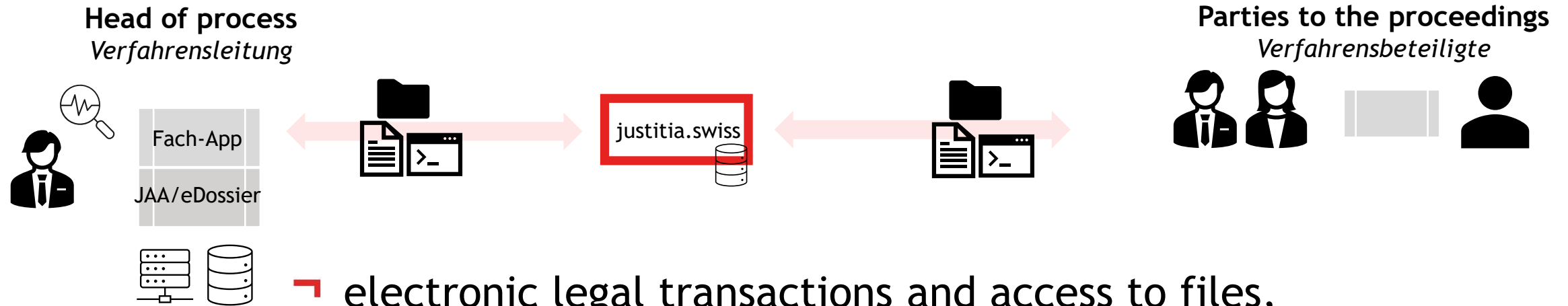

# justitia.swiss general concept

Marcel Ging





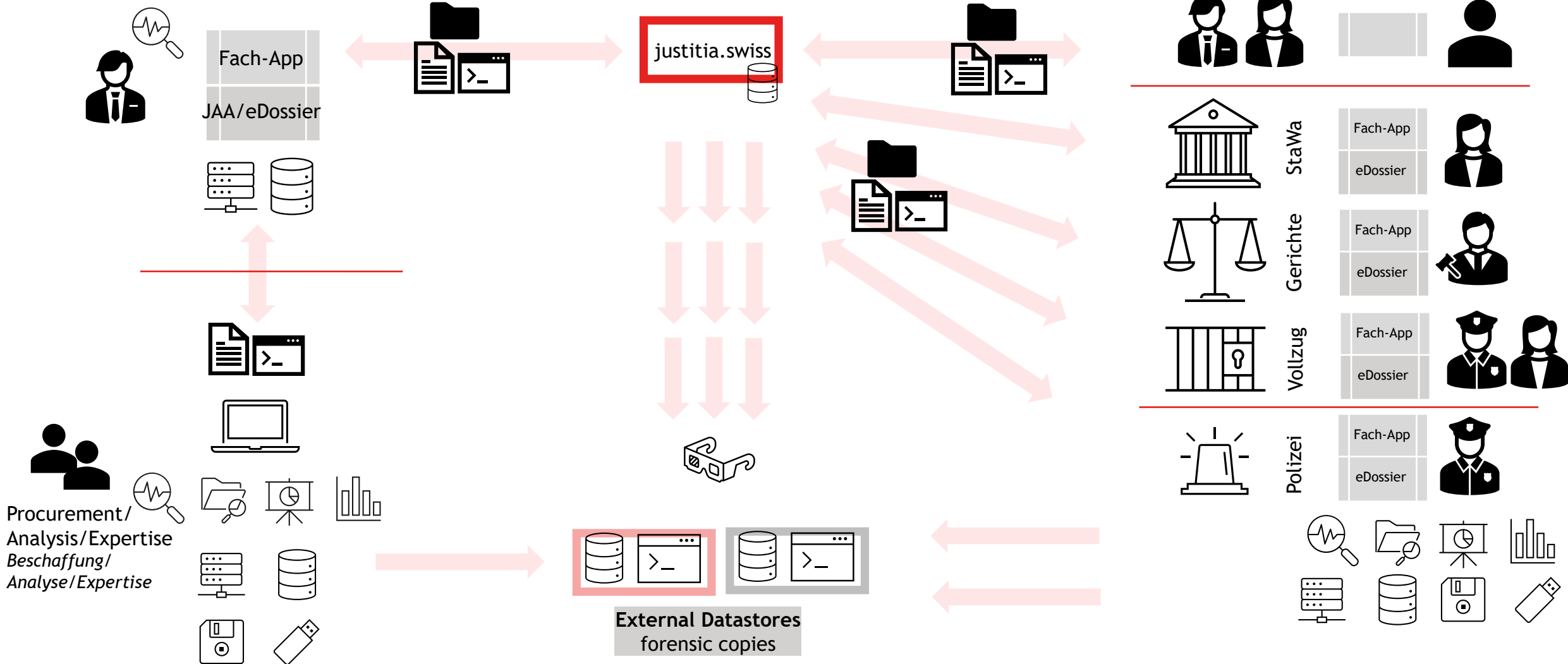
- electronic legal transactions and access to files, seals, receipts, address book of authorities
- communication via encrypted channels, digital identity check, virus check, encryption of files and metadata
- parties have profiles to which authorised users have access and can upload and download files

# justitia.swiss - a secure exchange platform

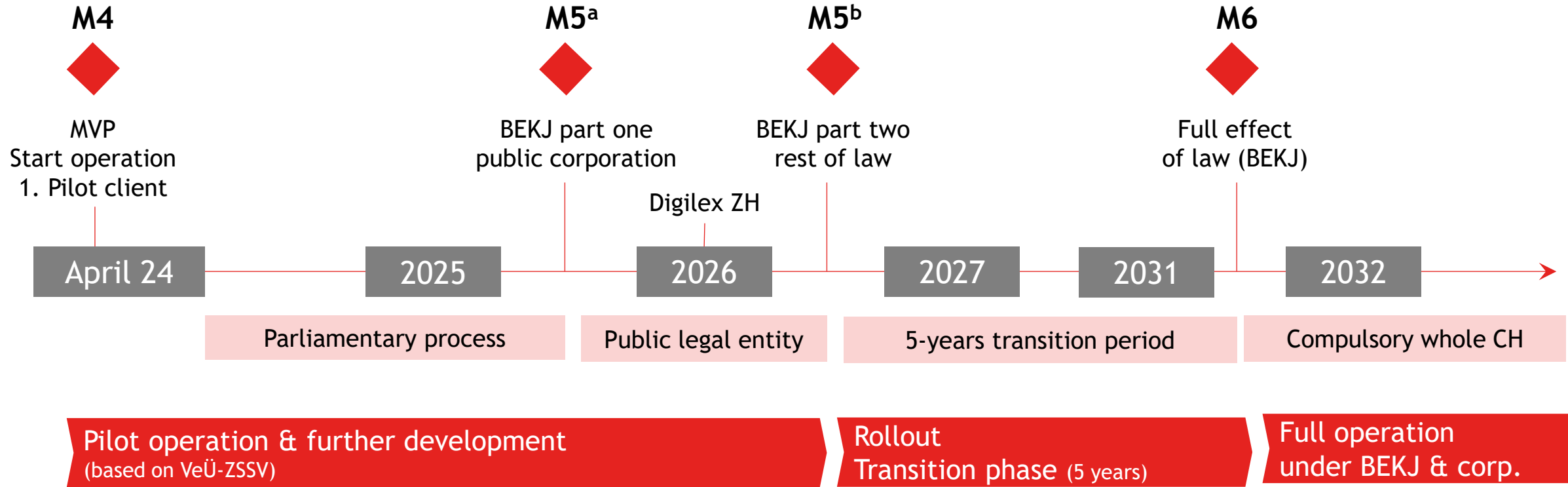


## Head of process Verfahrensleitung

# Roadmap of platform justitia.swiss - current working hypothesis



- in operation since April 2024
- high security standard
- all basic functions available

- easy to use (Web GUI & public API)
- operation and support organization
- training environment open to all

- We welcome proposals for new features, as long as they support the goals of the platform.
- The project team is responsible for deciding on the integration of new features.
- Once approved, the feature will be part of Sprint (3-weekly) Refined, Developed, Tested and Accepted
- Is later launched on TRAIN.
  - Preliminary descriptions (Release notes) to outline new feature
  - You might need to modify your code accordingly.
- Official launch on PROD wit release notes
- Full operational support
- When a feature is retired some API endpoints may be designated as deprecated.

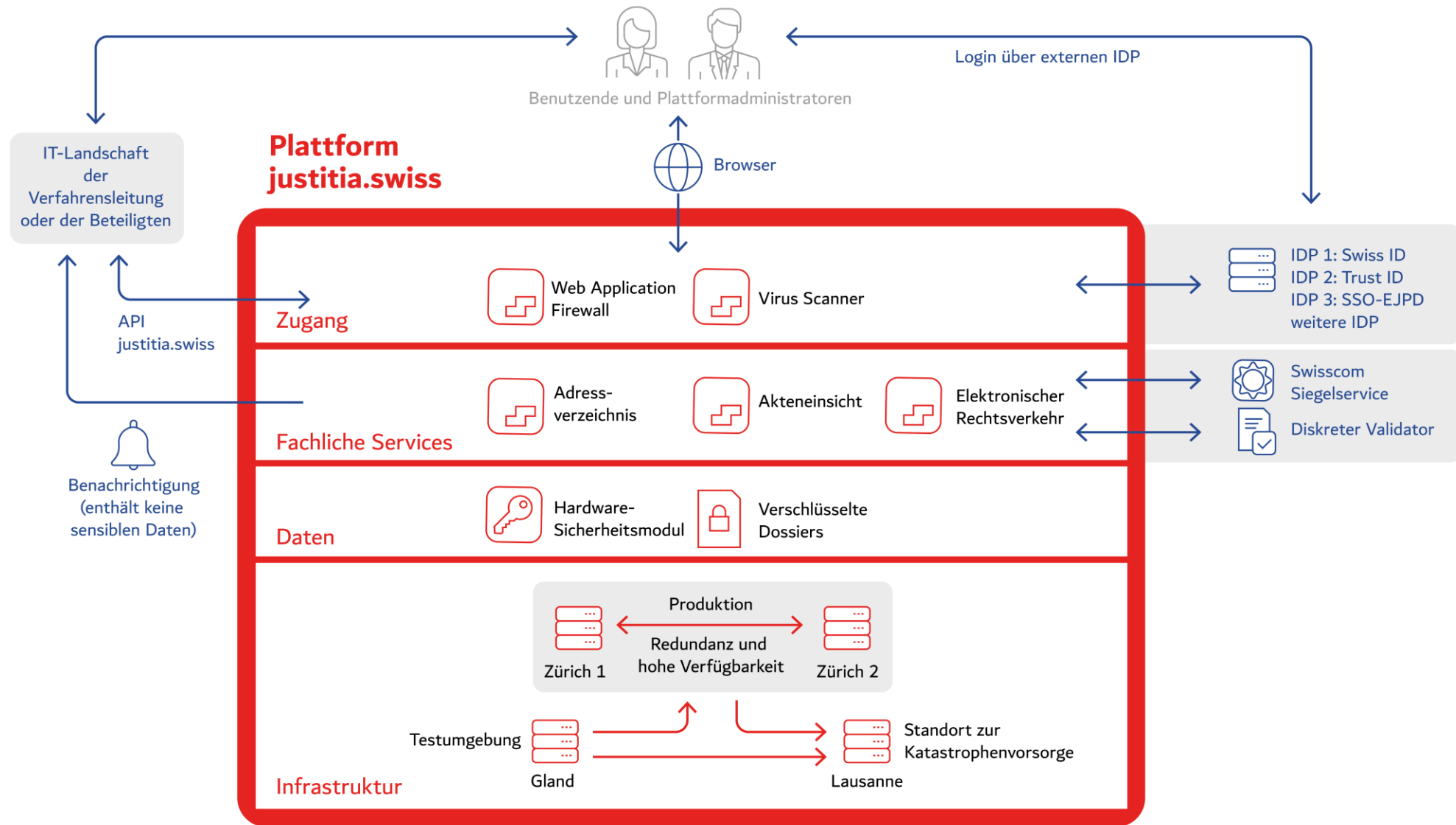

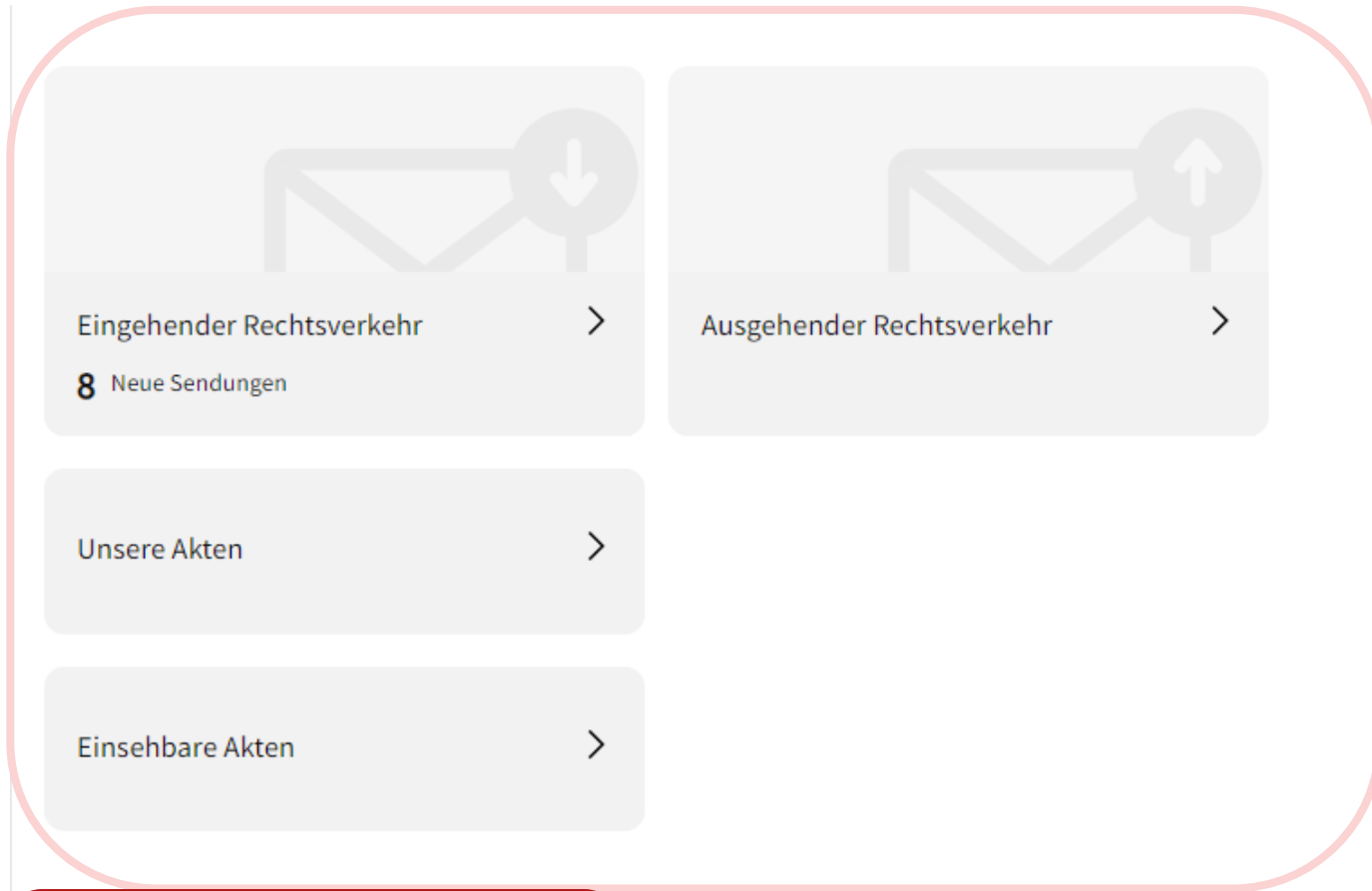

# What functions can be used via the API?



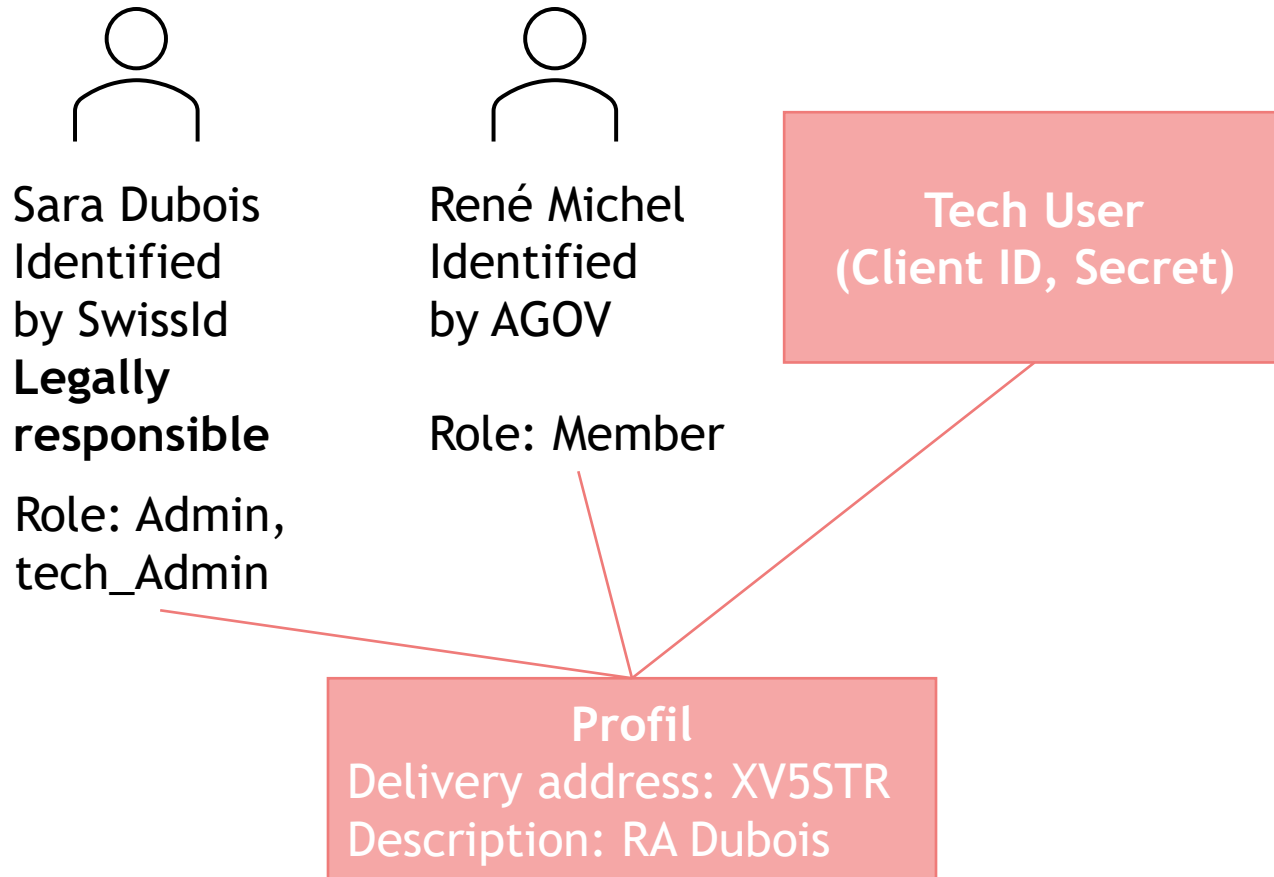
Via API:

Edit transmissions and dossiers.  
Transmit documents

Only via Web:

Editing profiles  
Inviting new members  
Creating and deleting technical users

# What a technical user is and may do



Technical users belong to a profile (like normal members)

Profiles with support for Tech Users: Authority Profile and Org-Profile

The security elements (Client Id and Secret) authenticate the technical user

→ They *must* be protected

→ The security elements are transferred to the specialised application according to *the protocol*

→ *No tech User with 'access to all profiles'*

- Create Profile on TRAIN Platform and create a technical user. Use Swagger, Postman and the development tool of your choice.
- Report issues at Support (<https://www.justitia.swiss/de/support/hotline>) :
  - Issues are Bugs, strange things happening.
  - Questions regarding features should be addressed to [info@justitia.swiss](mailto:info@justitia.swiss)
- End-2-End testing:
  - You might need to create a ‘test-authority’ to make control your end-2-end testing.
  - You might need to include your customers, your software and a partner at the other side

- Report bugs and help our support to quickly locate the issue:
  - The platform adds an HTTP header field **X-Request-ID** to all inbound requests and returns it with the response. The value of this field should be reported when support tickets are created, as it allows to trace requests in the log and therefore greatly simplifies error analysis.
- Is there a 1<sup>st</sup> Level Organization on your side? Yes, for authorities.
- We plan to support the User Agent Field in the HTTP Request. This will allow us to identify if you (or your software) is using deprecated endpoints or program around the framework.
- We decommission deprecated features after 1 year. (See Versioning on Doc. for developers)

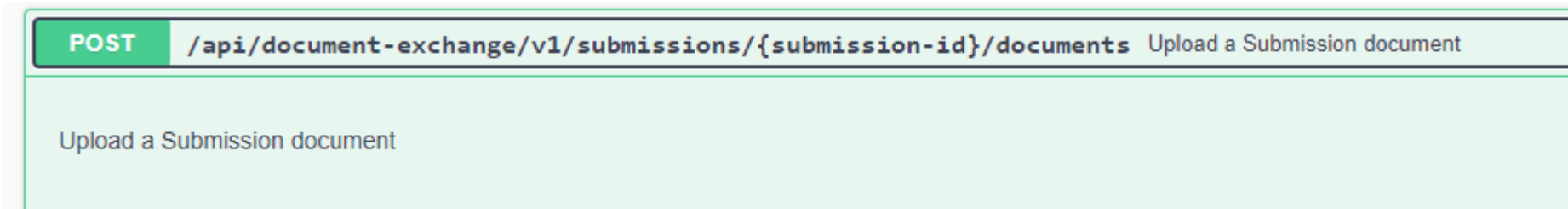

- 2) Upload via POST request:

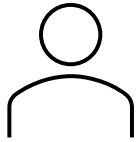

- The API (and soon the GUI) suggests to use references to the dossiers on both side of the communication



Sara Dubois

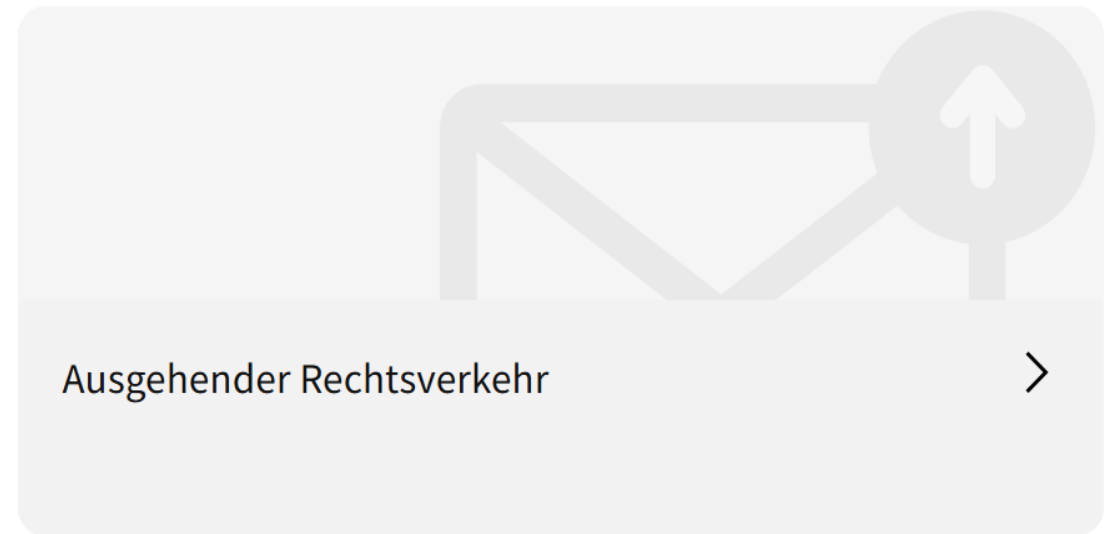
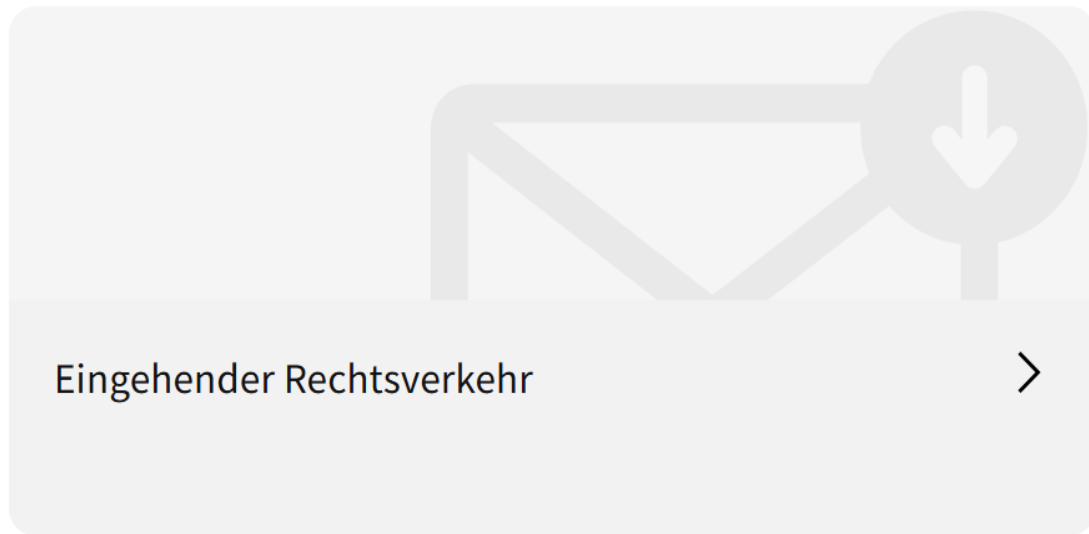


- Terms and Conditions to be accepted: Different on TRAIN and PROD
- Legally Responsible Person
- Split Transfers into different Transmissions: «Eingabe» «Zustellung» «Akteneinsicht»
- «Subject» for all kinds of Transmissions
- Fix Lifecycle of Documents and Dossiers
- Verification of (authority) seals
- Handling of filetypes for advanced use cases (IT-forensic, Decentral Storage, ...)

## Outbound legal traffic

- Compilation of legal document (incl. enclosures)
- Input control (adding or deleting documents)
- Check transferability, hash value tool
- Direct filing of legal document (including selection of addressee)
- Download and automatic filing of submission receipt
- Information about documents (metadata)
- Enabling submission on behalf of another person



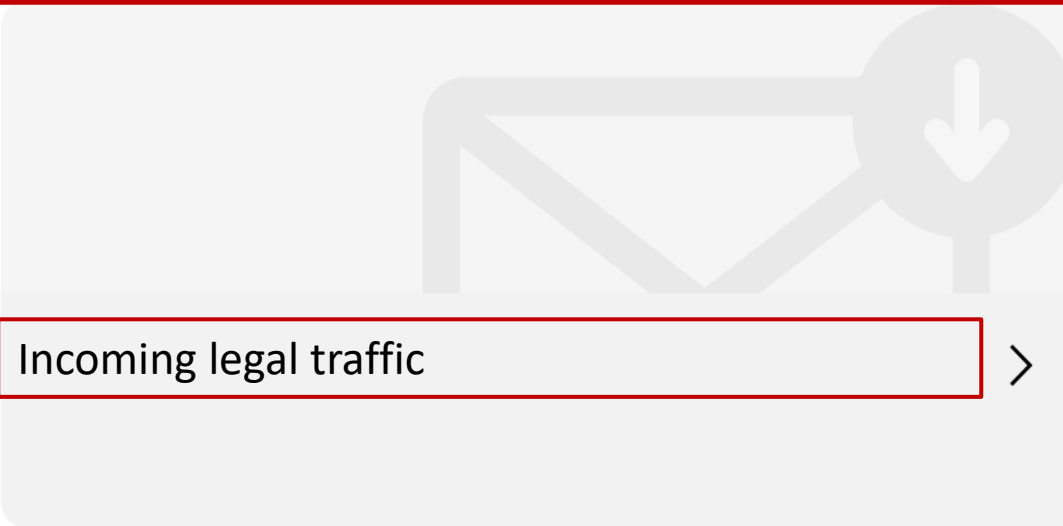

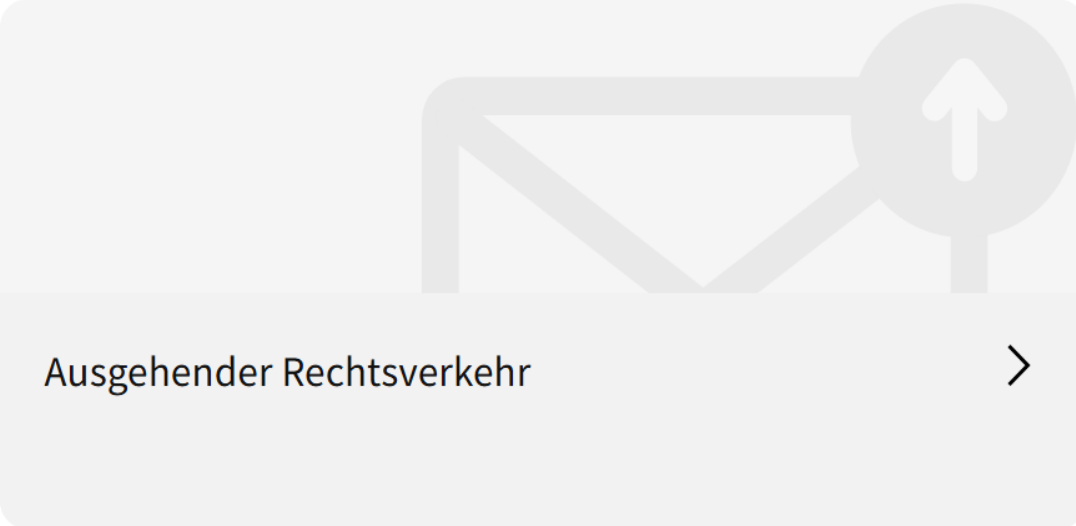

## Incoming legal traffic

- Notification of entry
  - Warning of triggering the deadline before download
  - Process for status of incoming legal traffic (e.g. unread, opened, notification of deadline, transmitted to the client)
  - Automatic filling of downloaded documents (including download receipt)
  - Hash value verification
  - Enabling download on behalf of another person
-  Direct download and storage of files without any additional steps

## Other general suggestions

- ➔ Make sure, that through the API, the same **size of data** that is allowed to be transferred on Justitia.Swiss can be uploaded and downloaded through the software.
- ➔ Journaling of all the transactions on Justitia.Swiss (e.g.: 06.01.2025 – 09:34 – Lawyer XYZ has filed PDF document «*2025.01.06. Request for divorce*» and PDF document «*2025.01.06. Attachments to request for divorce*» ; 07.01.2025 – 09:00 – Secretary ZYX has opened and downloaded following documents «...»)
